POLICIES & DISCLAIMERS:

CLASSES

- A credit card on file or post-dated cheques are required for all registrations (excluding Circus Tots) unless you are with a Distributed Learning Program.
- In addition to tuition, there is a \$28/year/student insurance fee. This fee is effective for 12 months from the date of your registration and will automatically be added to tuition on the anniversary date if the student is actively taking classes at that time.
- If monthly payments are to be split between two parties, the non-registering parent must contact us within 7 days of registration to put a credit card on file or provide post-dated cheques, otherwise full monthly payment defaults back to the registering parent.

CANCELLATIONS & MISSED CLASSES

- Cancellations with full refund can be made up to the first day of class, cancellations within the first three weeks pay for the first month only
- School credit for days missed due to illness or injury with a doctor's note
- Students may switch to another Circus Lab class within a session without penalty

Class cancellations are to be made via email to info@thecircuslab.ca. Until a formal cancellation request is received, you will still be responsible for payment even if your student does not attend class. Credit will not be given for any missed classes, however you are welcome to contact our office to arrange a make-up time/class. Make-up classes cannot be taken if the student is no longer an active student, and cannot be extended into a new session.

Weather policy: If Langley School District is closed, then so are we. Make-up classes can be arranged by contacting the office. We understand that conditions may vary throughout the Lower Mainland, and the safety of our students and parents is our priority. If we are still open but it is unsafe for you to come to class, please let us know and an alternate lesson can be arranged.

PRIVATE LESSONS

- Full payment is due the day of the lesson
- cancellation or scheduling changes must be made 24 hours prior to the lesson or full payment is still required.

CAMPS

- Full payment for the camp is required at registration
- 100% refundable up to 1 week prior to first camp start date, 80% refundable up to the first day of camp, non-refundable after camp start date

BIRTHDAY PARTIES/GROUPS

- \$75 deposit is required at the time of booking
- The deposit is 100% refundable up to two weeks prior to the event date, 80% refundable up to 48 hours prior to the event date
- Non-refundable less than 48 hours prior to the event date
- Dates can be switched to another open time without penalty

CLOSED STUDIO POLICY

From our experience, most students perform and learn better in classes when family members / friends are not watching. Please respect your child's learning environment by leaving the studio during their class.

WHAT TO WEAR

All students must wear athletic clothing; NO jeans, or any other clothing with zippers, buttons or velcro as these will all damage our aerial equipment. Hair should be pulled neatly and securely away from the face. ABSOLUTELY NO CELL PHONES OR OTHER ELECTRONIC DEVICES ARE TO BE USED NOR KEPT IN POCKETS WHILE ON THE FLOOR OR ON OTHER CIRCUS EQUIPMENT.

ARRIVAL AND PICKUP

Be sure your student arrives 5 minutes before (no earlier please) his/her scheduled class time. Please pick up your student on time. During peak times the parking lot may be crowded, and we need to be considerate of neighbouring business parking spots.

COACHES

Our coaches are all circus professionals and, as such, are occasionally called away for performance opportunities. We reserve the right to provide a substitute coach for any class without notice or provision for make-up/class credit etc.

PHOTOGRAPHY

I give my permission for photographs of my child/ren to be used by Circus Lab for promotional purposes.

DISCLAIMER

I wish to enroll my child in Circus Lab and understand that the personal training programs purchased hereunder includes participation in strenuous physical activities, including, but not limited to, acrobatic maneuvers, aerial acrobatics, trampoline, juggling and object manipulation, various ground, aerial and trampoline conditioning exercises, weight training, stretching, running, dancing, and various circus-art related programs (the "Activities"). I, the child's parent and/or legal guardian, understand the nature of the above referenced Activities and the child's experience and capabilities, and believe my child to be capable, in good health and in proper physical condition to participate in such Activities. I acknowledge that the Activities involved have an inherent risk of physical injuries or other damages, including but not limited to, death, paralysis, permanent disability, heart attacks, muscle strains, pulls or tears, broken bones, shin splints, heat exhaustion, various bodily injuries of all sorts, in addition to illness, soreness, over-exertion, slip and fall, or any unknown health problems of the child, caused or contributing to, during or after the child's participation by their actions or inactions, or those of others participating in the Activities, or by the conditions in which the event takes place, or by the negligence of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at the time and I fully accept and assume all such risks and all responsibility for losses, cost and damages I incur as a result of my child's participation in the Activities.

I acknowledge that if I believe any conditions are unsafe, I will immediately discontinue my child's participation in the Activities. I acknowledge that participation in Activities will be physically and mentally challenging, and agree that it is the responsibility of my child and I to seek competent medical advice regarding any concerns or questions concerning the child's abilities to participate. I acknowledge that such risks include but are not limited to, injuries caused by the negligence of Circus Lab, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activities take place, (each considered one the "Releasees" herein), or the use of defective or improperly used equipment. I further acknowledge the requirement to use protective equipment and recognize that my child will assume all responsibility for utilizing properly fitted protective equipment and agree to wear this protective equipment at all times while participating in Activities requiring this equipment.

I hereby release, discharge, and covenant not to sue the Releasees from all liability, claims, demands, losses, or damages, on my own account and on my child's account caused or alleged to be caused in whole or in part by the negligence of the Releasees, breach of contract, or breach of any statutory or other duty of care, including any duty of care owed under the *Occupiers Liability Act*, R.S.B.C. 1996, c. 337, in addition to negligent rescue operations and I agree that if, despite this release and waiver of liability, and assumption of risk, my child or I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, attorney fees, litigation expenses, or cost, which any Releasee may incur as the result of such claim. I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I understand that I, on my own behalf and on behalf of my child, have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. I understand that if there are any conflicts between the terms of this Agreement and any other agreement between us, the terms of this Agreement shall prevail.
